

**The Official Rules For The 2024 Monopoly “Double Play” Game At McDonald’s**  
(the “**Game**”)

**Official Rules** (the “**Official Rules**”)

The 2024 Monopoly Double Play Game is sponsored by McDonald’s Restaurants of Canada Limited (the “**Sponsor**”). The Sponsor in its sole and absolute discretion may engage certain third parties to administer various aspects of the Game on its behalf. In these Official Rules, the term Sponsor includes those third parties.

**Note: No Purchase of a McDonald’s Food or other product is required to play the Game and making such a purchase will not increase or affect a Participant’s (defined below) chances of winning a Prize (defined below) in the Game. Go to Rule III.B. for information respecting how to play or enter without a purchase.**

**Also Note: A Participant will need the McDonald’s app (defined below) in order to claim Prizes that are not Food Prizes (as defined below) in the Game (“Non-Food Prizes”) and participate in the Double Play (defined below) portion of the Game. (Refer to Rules IV.H. and VI for how to participate in the Double Play portion of the Game and claim Prizes using the McDonald’s app.)**

**Note:** McDonald’s Restaurants of Canada Limited has implemented an accessibility plan outlining its commitment to removing barriers for persons with disabilities or, when removing barriers is not possible, accommodating persons with disabilities in a timely, effective and suitable manner. Please refer to <https://www.mcdonalds.com/ca/en-ca/accessibility.html> for information.

**General Terms Used In These Official Rules:**

In these Official Rules, a person who is eligible to participate in the Game is referred to as a “**Participant**”.

The Game is open **only** to residents of Canada who are eligible to participate in the Game, as described in **Rule II** below. Except as otherwise specifically stated in these Official Rules, all times mentioned in these Official Rules are local time (“**Local Time**” or “**LT**”), which refers to the time of day at the location of a particular Game Participant in Canada. The period during which a Participant can play the Game is called the “**Game Period**” and is defined in **Rule I** below.

A game piece (a “**Game Piece**”) comprises two game stamps (each a “**Game Stamp**”). Each Game Stamp includes a unique 12-digit, alphanumeric code (“**Game Stamp Code**” or “**Code**”), which a Participant uses in the McD’s app (defined below) to claim a Prize and/or participate in Double Play (defined below) for an opportunity to win another Prize or to enter a Prize Draw. As described in these Official Rules, except in the case of Food Prizes (Prizes consisting of a food item, as more particularly described in these Official Rules), it is necessary for a Participant to have a Code to claim a Prize. The term “**Prize**” refers to “**Food Prizes**” and “**Non-Food Prizes**” that are available to be won by Participants in the Game. The term “**ARV**” means the approximate retail value of the applicable Prize and does not include applicable taxes. Note that all ARVs and dollar values in these Official Rules are stated in Canadian dollars (unless otherwise stated). The term “**Double Play**” refers to the portion of the Game that takes place in the McD’s app and provides Participants the opportunity to play for another chance to win a Prize when they scan or enter their Game Stamp Code in the McD’s app. The term “**McD’s app**” or “**McDonald’s app**” refers to the McDonald’s app available on the iOS and Android platform that is required to claim Prizes and play the Double Play portion of the Game. The term “**MyMcDonald’s Rewards Points**” refers to the Sponsor’s MyMcDonald’s Rewards program. The term “**Game Materials**” means, without limitation, any original Game Stamp(s), any Code(s), any document such as the declaration and release (a “**Declaration and Release**”) as well as any other document(s) which the Sponsor and/or the Redemption Centre (defined below), in its/their sole discretion, requires a Participant to complete and provide in order to properly claim a Prize in the Game. An “instant winning” Game Stamp (an “**Instant Win Game Stamp**”) is a single Game Stamp which potentially may win a Prize (an “**Instant Win Prize**”) in the Game (other than in Double Play). A “**Collect to Win Game Stamp**” is a Game Stamp that is part of a potential winning combination of Game Stamps in the Game. The combination of Collect to Win Game

Stamps that must be collected in order to form a potential winning combination for a Prize in the Game is called a **“Winning Combination”**. **“Minor”** means a person who is **not** of the age of majority in their province/territory of residence. The term **“Game Entities”** means in respect of the Game, collectively, the Sponsor and Hasbro Canada Corporation. The term **“Prize Claim Process”** means completing the instructions to claim a Prize. The term **“Prize Partners”** means, collectively: ArenaNet, LLC (Guild Wars 2); Autograph Authentic; Bloomex Canada; Capcom U.S.A. Inc. (Monster Hunter: World); Crunchyroll, LLC; COGNOSPHERE PTE. LTD. (Genshin Impact); DoorDash Technologies Canada Inc.; General Motors of Canada Company; Hudson’s Bay Company ULC; InComm Canada Prepaid, Inc.; Kennedy Space Center Visitor Complex (DNC Parks & Resorts at KSC Inc.); Keurig Canada Inc.; Leon’s Furniture Limited; MEA Mobile Ltd.; Michaels Stores, Inc.; My Custom Sports Chair, Inc.; Paramount Streaming Canada, a division of Paramount Entertainment Canada ULC; Pickleball Paddles Canada; Polaris Industries Inc.; Photo Prints+; Royal Bank of Canada; Ruby Crate; Sega of America, Inc. (Metaphor: ReFantazio); SkipTheDishes Restaurant Services Inc.; SteelSeries; Sunwing Vacations, Inc.; Things Engraved; Toys“R”Us (Canada) Ltd.; Uber Portier Canada Inc.; Universal City Development Partners, Ltd. d/b/a Universal Orlando Resort and Universal City Studios, LLC d/b/a Universal Studios Hollywood (collectively referred to herein as **“Universal”**); Vasanti Cosmetics Inc.; Wal-Mart Canada Corp.; and Zynga Inc. (Top Troops), all participating in the Game. The term **“Redemption Centre”** means the organization, retained by the Sponsor, that is responsible for dealing with matters involved in the verification of applicable Prize claims, the redemption of verified winning Instant Win Game Stamps and verified Winning Combinations, conducting the Prize Draws, contacting Prize Draw winners and, subject to these Official Rules, the fulfillment of Non-Food Prizes in the Game.

**Note:** Subject to the provisions of these Official Rules, before any Participant who is a potential winner of a Prize in the Game can be declared a winner of the applicable Prize, they (or, in the case of a potential winner who is a Minor, that Minor’s parent or legal guardian) first must correctly answer a mathematical skill-testing question (the **“Skill-Testing Question”**) without assistance of any kind, whether electronic, mechanical or other. The Skill-Testing Question will be provided to potential winners of Prizes in the manner specified in these Official Rules.

**Official Rules And The Sponsor’s Decisions Bind Participants:**

The Game is being conducted in Canada by the Sponsor in accordance with these Official Rules. By participating in the Game, each Participant, and if the Participant is a Minor, that Minor's parent or legal guardian on behalf of the Minor, unconditionally accepts and agrees to comply with and abide by these Official Rules (which are available for review at participating McDonald's restaurants in Canada and online in the McD's app and at [mcdpromotion.ca](http://mcdpromotion.ca), the game website ("**Game Website**")) and by the decisions of the Sponsor or their designee with respect to the Game, including, without limitation, the meaning and application of these Official Rules. Sponsor or their designee's decisions shall be final and binding upon all Participants with respect to all aspects of the Game.

### **Rule I: General Description Of The Game.**

To play the Game, a Participant must obtain Game Pieces in the manner(s) described below in these Official Rules (refer to **Rule III.B.1.** and **III.B.2.**), and, subject to verification, collect a potential Winning Combination of Game Stamps or get a single Instant Win Game Stamp. To participate in the Double Play portion of the Game (refer to **Rule IV.H.**), Participants must use the McD's app.

#### **A. There Are Three Ways To Play And Potentially Win A Prize In The Game:**

- a. Obtain a potential Instant Win Game Stamp (refer to **Rule III.B.** below);
- b. Obtain Collect to Win Game Stamps that comprise a potential Winning Combination (refer to **Rule III.B.** below); and
- c. Scan or enter the Game Code on any Game Stamp in the McD's app to Double Play for another chance to win Prizes (refer to **Rule IV.H.** and **Rule IV.L.**).

**Note:** There is no limit to the number of Prizes that a Participant can win in the Game.

The Game Period begins on October 1, 2024, and will end on the later of (i) November 4, 2024 (the "**Scheduled End Date**"), or (ii) the date on which there are no longer any supplies remaining in any participating McDonald's restaurant in Canada of specially-marked packaging items to which Game Pieces are affixed. Note that the Scheduled End Date of November 4, 2024, is subject to a corresponding extension if the in-restaurant portion of the Game runs long in restaurants. Code Entry for Double Play in the McD's app will end on **November 4, 2024, at 11:59:59 p.m. LT.** Refer to **Rule III.C.** for additional information concerning the planned Game schedule.

Refer to **Rule IV** for a list of the Prizes available to be won in the Game and the chances of winning each such Prize, **as of the start of the Game Period.**

**B. Summary of Important Dates in the Game:**

**Rule II: Who Is Eligible To Play The Game.**

**A. Who Can Play:**

Subject to the provisions of these Official Rules including, without limitation, the restrictions on eligibility set out below in Rule II.B., the Game is open **only** to residents of Canada. The Double Play portion of the Game found in the McD's app requires that the participant be **fourteen years of age or older** to participate.

**B. Restrictions On Eligibility: Individuals Who Are Not Eligible To Participate In The Game:**

Persons in any of the following categories are **not** eligible to participate in, or to win a Prize in, the Game: (a) any person who, on or after May 1, 2024, was or is a director, officer, employee, member, manager, agent or franchisee of any one or more of the following: any of the Game Entities, or any one or more of their respective divisions, parents, subsidiaries, affiliated or related companies, franchisees, advertising and promotional agencies, representatives, service agencies or independent contractors; (b) any individual engaged in the development, production or distribution of materials for the Game including the Redemption Centre; (c) any person who, on or after May 1,

2024, was or is a director, officer, member, manager, agent or franchisee/dealer of one or more of the Prize Partners, or of any Prize Partner's divisions, parent company, subsidiaries, affiliated or related companies, dealers and dealerships, franchisees, representatives, service agencies or independent contractors; however, the employees of such Prize Partners may participate in the Game but are not eligible to receive and may not claim any Prize supplied or provided by the Prize Partner or by an affiliated or parent company of the Prize Partner **for which they work**; and (d) any person who is or purports to be an immediate family member (defined as spouse, dependent for federal income tax purposes, siblings, or step-, biological, foster, in-law or adoptive parents, siblings or children) of, or who resides or is domiciled in the same household as, any person in any of the preceding categories.

**Rule III: How To Obtain A Game Board, How To Obtain A Game Piece Bearing Game Stamps, The Game Schedule And Transfers Of Game Stamps.**

**A. How To Obtain A Game Board:**

A Game Board is not required to play the Game. A Participant can obtain an official game board (a "**Game Board**") for the Game in one or more of the following ways:

1. while supplies last, at any participating McDonald's restaurant in Canada;
2. at the sole discretion of the Sponsor via direct mail, or newspaper insert, or otherwise until the Game ends; and
3. by visiting [mcdpromotion.ca](http://mcdpromotion.ca) or by tapping on the Monopoly promotional banner in the McD's app. Note that if a Participant uses the McD's app or Game Website to obtain a Game Board, they must print out the Game Board at their own cost.

**B. How To Obtain A Game Piece To Play The Game:**

As described below, Game Pieces can be obtained, while supplies last, at a participating McDonald's restaurant on specially-marked packages of food items to which Game Pieces are affixed, or a Participant can get a Game Piece without making a purchase.

**1. How To Get A Game Piece On Specially-Marked Packages By Making A Food Purchase In The Game:**

A Participant can get a Game Piece by visiting a participating McDonald's restaurant in Canada during the Game Period and purchasing a food item that is contained in

specially-marked packages, available while supplies last. One Game Piece is affixed to the following specially-marked food items: medium and large hot **McCafé**<sup>®</sup> beverages (Premium Roast Brewed Coffee, Tea, Mocha, Latte, Cappuccino, Americano and Hot Chocolate); extra-large hot **McCafé**<sup>®</sup> beverages (Premium Roast Brewed Coffee or Tea only); medium and large Fountain Drinks; medium and large **Triple Thick Milkshake**<sup>®</sup>; **Big Mac**<sup>®</sup> sandwich; Double **Big Mac**<sup>®</sup> sandwich; **Quarter Pounder**<sup>®</sup> sandwich; **Quarter Pounder with Cheese**<sup>®</sup> sandwich; Double **Quarter Pounder with Cheese**<sup>®</sup> sandwich; **Quarter Pounder**<sup>®</sup> BLT sandwich; **Big Arch**<sup>™</sup> sandwich; Double **Quarter Pounder**<sup>®</sup> BLT sandwich; **McChicken**<sup>®</sup> sandwich; Spicy Habanero **McChicken**<sup>®</sup> sandwich; **McCrispy**<sup>®</sup> sandwich; Spicy **McCrispy**<sup>®</sup> sandwich; Firecracker **McCrispy**<sup>®</sup> sandwich (when available); Firecracker **McCrispy**<sup>®</sup> with Bacon sandwich (when available); Cajun Ranch **McCrispy**<sup>®</sup> sandwich (when available); Cajun Ranch **McCrispy**<sup>®</sup> with Bacon sandwich (when available); Bacon Deluxe **McCrispy**<sup>®</sup> sandwich; Spicy Bacon Deluxe **McCrispy**<sup>®</sup> sandwich; 10-piece **Chicken McNuggets**<sup>®</sup>; large Fries; **McMuffin**<sup>®</sup> sandwiches: **Egg McMuffin**<sup>®</sup> sandwich, BLT **Egg McMuffin**<sup>®</sup> sandwich, Bacon 'N **Egg McMuffin**<sup>®</sup> sandwich, Sausage 'N **Egg McMuffin**<sup>®</sup> sandwich (excludes **Sausage McMuffin**<sup>®</sup> sandwich, **Mighty McMuffin**<sup>®</sup> sandwich and **Chicken McMuffin**<sup>®</sup> sandwich); Hash Brown. Two Game Pieces are affixed to specially-marked 20-piece **Chicken McNuggets**<sup>®</sup>.

Specially-marked packages referred to above are available for the applicable menu item during the hours when that menu item is served, while supplies last. The hours during which particular menu items are served vary at some participating McDonald's restaurants in Canada.

As the Game progresses, some forms of the specially-marked packages referred to above may run out before others and may not be replenished. Refer to the planned Game schedule below.

## **2. How To Get A Game Piece In The Game Without Making A Food Purchase:**

A Participant has an alternative means of entry into the Game (an "AMOE"). A Participant can request a Game Piece, without buying a food item, by mailing a request (a "Request") as follows:

- the Request must be mailed in a postage-paid outer envelope;

- the Participant's complete return mailing address must be included on the outer envelope;
- within the outer envelope there must be one self-addressed envelope that uses the Participant's complete mailing address;
- the self-addressed envelope must bear sufficient return postage;
- the outer envelope must be mailed to:

**Note: Do Not Send Any Potential Winning Game Materials, Comments Or Questions To This Address.** Each Request must be mailed in a separate outer envelope (i.e., only one Request per outer envelope). Both the mailing and return addresses on the exterior envelope must be legible. Envelopes with no return address on the outside will **not** be honoured. Requests that fail in any way to comply with the requirements set out above in this sub-paragraph or that are not mailed separately (i.e., only one Request per outer envelope) bearing sufficient postage will **not** be honoured. While supplies last, one Game Piece (consisting of two Game Stamps) will be mailed in response to each Request that complies with these requirements. **The outer envelopes bearing the Requests must be postmarked no sooner than September 24, 2024, and no later than November 4, 2024, and actually received at the above address no later than November 11, 2024, to allow adequate time for processing. Note that Double Play entry ends November 4, 2024, so requests that are received less than two weeks prior to November 4, 2024, may not result in the Participant receiving the Game Piece in time to enter for Double Play, but any Prize revealed on the Game Stamp may be claimed in the McD's app until November 25, 2024 (except a Food Prize, which must be redeemed at the restaurant by 11:59:59 p.m. LT on November 25, 2024 (or restaurant closing)).**

**Note Carefully:** Game Stamps are null and void and will be rejected if the Sponsor finds that they were not obtained through authorized, legitimate channels. "**Legitimate Channels**" do **not** include purchasing or obtaining Game Stamps online or at live auctions. If any part of any Game Stamp is counterfeited, or if any Game Stamp comes from other games or promotions, or if any part of any Game Stamp is illegible in whole or in part, washed, erased, mutilated, eaten, damaged or tampered with in any way, or if any Game Stamp contains or reflects printing, typographical, mechanical or other



errors or omissions, the Game Stamp will be rejected and will be deemed void and invalid. Each Participant acknowledges and agrees that the decisions of the Sponsor and the Redemption Centre shall be final, binding and conclusive in all matters relating to the Game, including, without limitation, Double Play determinations regarding a potential Prize winner's eligibility to win a Prize and/or the validity, state or status of Game Stamps submitted for verification. Only Game Stamps with the 2024 Monopoly Double Play Game artwork will be accepted for verification. Any person attempting in any way to forge or alter any Game Stamps or to create materials in an apparent attempt to defraud or mislead the Sponsor in any way in connection with the 2024 Monopoly Double Play Game will be disqualified from participation in the Game and will be prosecuted to the fullest extent permitted under the law.

**C. The Planned Game Schedule:** It is planned that Game Pieces will be available in participating McDonald's restaurants in Canada on specially-marked packages beginning on or about October 1, 2024, and ending on or about November 4, 2024. However, Game Pieces that remain in participating McDonald's restaurants in Canada on November 5, 2024, will be distributed to the public until they are gone (but in no event later than the Prize redemption deadline of **11:59:59 p.m. on November 25, 2024**), at which point the Game will end. As a result, as the Game progresses, some participating McDonald's restaurants may complete distribution of their supply of Game Pieces before others. Similarly, Game Pieces may be depleted on some forms of packaging before others. Reference **Rule X.B.** for possible Force Majeure events that could impact the planned Game schedule. **Note:** Double Play in the McD's app ends at **11:59:59 p.m. LT on November 4, 2024.**

**D. Transfers Of Game Stamps:** Any transfer, whether by way of sale, loan, gift, handover, gaming or gambling activity or any other manner whatsoever, of any Game Materials, including without limitation, a Game Stamp, by an ineligible person to an eligible person is strictly prohibited. The transfer by a Participant of any Game Materials, including without limitation, a Game Stamp to any other person by any means whatsoever (including without limitation by any of the above-mentioned means) is strictly prohibited **except as follows:**

- a Minor **must** transfer Game Stamps to the Minor's parent/legal guardian to claim a Prize (except a Food Prize) on the Minor's behalf; or

- if a Participant who is the potential winner of a Prize wishes to transfer the Prize or the related potential winning Game Stamp, or potential Winning Combination, as the case may be, to another person, subject to these Official Rules that transfer **must** be requested in writing, signed and mailed along with the Game Materials when submitted to the Redemption Centre **before** any transfer is made. Authorization may be granted or withheld in the Sponsor's sole discretion.

Any Game Materials (including a Game Stamp) which are determined by the Sponsor to have been the subject of a prohibited transfer are subject to disqualification at the sole and absolute discretion of the Sponsor, and any person who is determined by the Sponsor to have been involved (either as transferor or transferee) in a prohibited transfer is subject to disqualification at the sole and absolute discretion of the Sponsor.

#### **Rule IV: How To Play The Game, The Prizes, The Odds Of Winning.**

To play the Game, first obtain a Game Piece containing two Game Stamps. Then carefully peel each Game Stamp from its backing on the Game Piece or from the specially-marked package to which the Game Piece is affixed. Determine if each Game Stamp is an Instant Win Game Stamp, which potentially may win a Prize, or is a Collect to Win Game Stamp which is part of a potential Winning Combination in the Game. Note that **Rule VI** outlines how to claim a Food Prize, an Instant Win Prize, a Collect to Win Prize, and a Double Play Prize, as well as provides details and deadlines in the Game. Whether or not the Game Stamp is an Instant Win Game Stamp, the Game Code from the Game Stamp can be used to participate in Double Play for an opportunity to win another Prize (refer to Rule IV.L.).

#### **A. Monopoly Game Stamp Prize Distribution, Numbers, And Approximate Chances Of Winning (the "Odds"):**

Potential winning Game Stamps are distributed on a generally random basis across the universe of Game Stamps. It is planned that approximately one hundred eight million, four hundred fifty-one thousand, nine hundred seventy-five total Game Pieces (two Game Stamps per Game Piece) will be distributed during the Game Period. The overall Odds of a Participant winning a Prize on a Game Stamp(s) as of the outset of the Game are 1 in 5, based on the planned number of Game Pieces.

In addition to any terms and conditions noted in each Prize description, all Prizes are

subject to the Prize Conditions set out in this Rule IV below.

**Note:** The approximate number of Prizes available to be won in the Game, and the Odds of winning Prizes, which are set out in these Official Rules, are stated as of the outset of the Game. The number of Prizes available to be won will diminish as the Game progresses, and the Odds of winning Prizes will change as Prizes are claimed.

**B. Monopoly Instant Win Game Stamps:** If an Instant Win Game Stamp identifies a Prize that is an Instant Win Prize in the Game (refer to Rule IV.C., D. and .E.) the Participant who possesses that Instant Win Game Stamp is the potential winner of that Prize, subject to verification of the potential winning Instant Win Game Stamp (where applicable) and of the Participant's compliance with these Official Rules.

**C. Monopoly Instant Win Food Prizes:** Based on a random distribution of approximately one hundred eight million, four hundred fifty-one thousand, nine hundred seventy-five total Game Pieces, it is planned that on those Game Pieces, approximately sixteen million, one hundred thirty-three thousand, nine hundred fourteen Food Prizes will be available to be won at the outset of the Game. The overall Odds of winning a Food Prize on a Game Stamp as an Instant Win Prize as of the outset of the Game are approximately 1 in 6.73, based on the number of Game Pieces (each Game Piece comprises two Game Stamps), which it is planned will be distributed during the Game Period. In the event that fewer Game Pieces are distributed, the number of available Food Prizes will be lower, but will maintain the 1 in 6.73 Odds. The Odds of winning a specified Food Prize on a Game Stamp as an Instant Win Prize, as of the outset of the Game, and the ARV of each specified Food Prize, are outlined below. **Instant Win Food Prizes must be claimed in participating McDonald's restaurants in Canada by 11:59:59 p.m. (or restaurant closing if earlier) on November 25, 2024.** Information to claim this Prize is in **Rule VI.**

**Note:** If you wish to use the Code on an Instant Win Food Prize Game Stamp for Double Play, make certain you Double Play before redeeming the Instant Win Food Prize at a McDonald's Restaurant in Canada, because once redeemed, the Game Stamp will not be returned.

**1. Cheeseburger:** It is planned that approximately three million, two hundred twenty-six thousand, seven hundred seventy-nine Cheeseburgers will be available to be won in the Game; Odds: approximately 1 in 34; ARV: \$2.79.

**2. Baked Apple Pie:** It is planned that approximately three million, two hundred twenty-

six thousand, seven hundred seventy-nine Baked Apple Pies will be available to be won in the Game; Odds: approximately 1 in 34; ARV: \$1.59.

**3. Small Hot McCafé® Beverage:** It is planned that approximately three million, sixty-five thousand, four hundred forty-one Small (10 oz.) Hot **McCafé®** beverages will be available to be won in the Game; Odds: approximately 1 in 36; ARV: \$1.00.

**4. Small Fountain Drink:** It is planned that approximately one million, four hundred fifty-two thousand, fifty-seven Small (16 oz.) Fountain Drinks will be available to be won in the Game; Odds: approximately 1 in 75; ARV: \$1.99.

**5. Medium Fries:** It is planned that approximately three million, five hundred forty-nine thousand, four hundred sixty-four Medium Fries will be available to be won in the Game; Odds: approximately 1 in 31; ARV: \$3.99.

**6. **Non-Supported Browsers and Operating Systems:**

Using a browser or device not supported may prevent access to the Game.

While all efforts are made to support current browsers, operating systems and devices, new operating systems, browsers and devices may not be supported if brought to market after the development of the Game and may affect the Participant's experience in the McD's app when they tap on the Monopoly promotional banner. Sponsor is not responsible for any browser, operating system or device supporting issues.

Throughout the Game Period, a Participant who is fourteen years of age or older can access the McD's app on their phone or tablet and tap on the Monopoly promotional banner to participate in the digital portion of the Game, following all applicable directions. For greater certainty, Participants who are under the age of fourteen must have their parent or legal guardian play in the McD's app on their behalf, and Participants who are fourteen or older but under the age of majority will require a parent or legal guardian to claim any Prize on their behalf except for Food Prizes.

Any Food Prizes or MyMcDonald's Rewards Points won and claimed via Double Play will deposit in the Rewards & Offers section of their McDonald's app account within approximately twenty-four hours.

See Prize Conditions in **Rule VII.A.4.** and winner notification information in **Rule IV.O.**

#### **Rule VI: Claiming A Prize In The Game.**

**Original Game Stamp(s):** A Participant must keep their original potential winning Game Stamp(s) because the Participant may need to submit the Game Stamp(s), and/or the Code on the Game Stamp(s), in order to claim the applicable Prize. For the purposes of making a valid Prize Claim, no entry of a Code in the McD's app when you tap on the Monopoly promotional banner is, or shall be accepted as, proof of the existence, the possession or the ownership, at any time, by a Participant of any Game Stamp or Stamps that bear a Code entered by a Participant in the McD's app.

**The first Participant to validly enter a particular Game Stamp Code in the McD's app by tapping on the Monopoly promotional banner and submitting the associated Game Stamp(s) to the Redemption Centre in order to claim a Prize (if applicable) will be the only Participant who can make a valid Prize Claim using that particular Game Stamp Code(s).**

**Forfeiture:** If, for any reason, a Prize is forfeited, then the applicable Prize will not be awarded, and the potential Prize winner will not have any claim against the Game Entities or against any other person, firm or corporation in respect of the applicable Prize or any matter related to the Game.

**A. General Information For Prize Claim:**

**Eligibility Requirement For Claiming a Prize:** There is no age limit for claiming a Game Stamp Instant Win Food Prize in the Game. In order to claim a Non-Food Prize (either Instant Win Non-Food Prize, Double Play Non-Food Prize or Collect to Win Prize) in the Game, a Participant must be the age of majority in their province/territory of residence as of the date the Prize is being claimed or must be the parent/legal guardian of a Minor who is a potential Prize winner.

**The Age of Majority for the following provinces is eighteen years old:** Alberta, Manitoba, Ontario, Prince Edward Island, Quebec and Saskatchewan.

**The Age of Majority for the following provinces/territories is nineteen years old:** British Columbia, New Brunswick, Newfoundland and Labrador, Northwest Territories, Nova Scotia, Nunavut and Yukon.

If a potential winner of a Non-Food Prize is a Minor in their province/territory of residence, the applicable Prize will be awarded in the name of that winner's parent/legal guardian, who correctly answers the Skill-Testing Question without assistance of any kind, whether electronic, mechanical or other, executes all documents and agrees to all obligations and undertakings of the potential (and of an actual) Prize winner, both on behalf of themselves and the Minor. If the parent/legal guardian does not meet these conditions, the Prize will be forfeited, the applicable Prize will not be awarded in the Game and the Prize claimant will not have any claim against the Game Entities or against any other person, firm or corporation in respect of the applicable Prize or the Game, or any matter related to the Game.

**B. Steps to Claim a Prize in the McDonald's app (except a Game Stamp Instant Win Food Prize):**

**To claim any Prize in the McDonald's app (except a Game Stamp Instant Win Food Prize):**

**1. Tap on the Monopoly promotional banner by 11:59:59 p.m. on November 25, 2024.**

**2. Complete Profile/Registration.** Complete your Profile (if you haven't already) and correctly answer a Skill-Testing Question.

**3. Claim A Prize.**

**(a) Claim a Game Stamp Prize.** If you are attempting to claim an Instant Win Prize or Collect to Win Prize, select "Add Code" in the navigation bar, enter the 12-digit Game Stamp Code(s) and you will receive a message that verifies the Game Stamp or potential Prize that is represented on the Game Stamp.

**(b) Double Play Prize Claim.** If you are attempting to claim a Double Play Prize, follow the prompts to complete the claim form.

If you are a potential winner, start by selecting "Claim Prize" in the navigation bar to follow the instructions to begin the Prize Claim Process necessary to claim the potential Prize. If the Participant is a Minor, they must have their parent or legal guardian be present to continue with the claim process on behalf of the Minor. The parent/legal guardian must confirm that they are the parent or legal guardian of the Participant. The Participant (or in the case of a Minor, their parent or legal guardian) must select "Start Claim"; read carefully, and in full, the Privacy Policy, Official Rules and Terms & Conditions, and click continue, acknowledging that they will comply with the Official Rules and Terms & Conditions. The Participant must then enter their last name, phone number (including area code) and complete mailing address including apartment and suite and in the case of a parent/legal guardian accepting on behalf of a Minor, the parent/legal guardian must enter their first name, last name, phone number, email address, full mailing address including apartment or suite, and the first and last name of the Minor. Then, the Participant (or in the case of a Minor, their parent or legal guardian) must confirm the accuracy of all the information submitted by selecting "Submit".

### **C. Prize Claim Deadlines & Additional Claim Information:**

**Note:** Before you claim a Food Prize in restaurant, make sure you use the Game Stamp Code in the McD's app to Double Play for the chance to win another Prize. Once you redeem a Food Prize in restaurant, the Game Stamp will not be returned.

#### **1. Claim A Monopoly Game Stamp Instant Win Food Prize:**

**(a) Deadline: Claim in-restaurant by 11:59:59 p.m. (or restaurant closing) on November 25, 2024.**

**(b) To Claim:** Potential winning Instant Win Game Stamps for McDonald's food items that are Food Prizes in the Game may be claimed at the counter, at a kiosk or at the Drive Thru at any participating McDonald's restaurant in Canada. Before placing a food order, a Participant must inform a McDonald's restaurant counter person or, if applicable, a Drive Thru McDonald's person, that they wish to claim a Food Prize, and then should present their potential winning original Food Prize Instant Win Game Stamp to that McDonald's person. A Participant may wish to claim only their Game Stamp for the applicable Instant Win Food Prize or may wish to continue to order additional food items. One Food Prize allowed per purchase. Once the Participant completes and confirms their food order, a receipt will be printed which the Participant must take to any register at the front counter to pick up their food order. When the Participant goes to the front counter register, they should present the receipt and the original potential winning Food Prize Instant Win Game Stamp to the McDonald's counter person and complete payment for any additional food



items (if applicable).

## **2. Claim A Double Play Food Prize:**

**(a) Deadline: Double Play in the app by 11:59:59 p.m. on November 4, 2024.**

**(b) To Claim:** When you win a Food Prize via Double Play, the Food Prize will deposit in the Rewards & Offers section of your McD's app account within approximately twenty-four hours. The Food Prize can also be applied to a McDelivery order. Food Prizes won from Double Play will expire at **11:59:59 p.m. on November 25, 2024.**

## **3. Claim A Monopoly Game Stamp Instant Win MyMcDonald's Rewards Points Prize:**

**(a) Deadline: Claim by 11:59:59 p.m. on November 25, 2024.**

**(b) To Claim:** After you claim a MyMcDonald's Rewards Points Prize in the McD's app, allow approximately twenty-four hours for the points to appear in the Rewards & Offers section of your McDonald's app account. Points expire on the first day of the month after the sixth month from the date such points were earned, except where prohibited by law. MyMcDonald's Rewards Points are not assignable or transferrable between accounts or otherwise, and points cannot be combined across accounts, regardless of who registered the account. Limit one redemption per order. Use of MyMcDonald's Rewards Points are subject to the terms and conditions of the MyMcDonald's Rewards program, available at [www.mcdonalds.ca/myrewardsterms](http://www.mcdonalds.ca/myrewardsterms) or on the McDonald's app. MyMcDonald's Rewards Points Prizes won in the Game will be deposited in your McDonald's app account when you win the Prize.

## **4. Claim A Double Play MyMcDonald's Rewards Points Prize:**

**(a) Deadline: Double Play in the app by 11:59:59 p.m. on November 4, 2024.**

**(b) To Claim:** When you win a MyMcDonald's Rewards Points Prize via Double Play, the MyMcDonald's Rewards Points Prize will deposit in the Rewards & Offers section of your McD's app account within approximately twenty-four hours. MyMcDonald's

Rewards Points expire on the first day of the month after the sixth month from the date such points were earned, except where prohibited by law. MyMcDonald's Rewards Points are not assignable or transferrable between accounts or otherwise, and points cannot be combined across accounts, regardless of who registered the account. Limit one redemption per order. Use of MyMcDonald's Rewards Points are subject to the terms and conditions of the MyMcDonald's Rewards program, available at [www.mcdonalds.ca/myrewardsterms](http://www.mcdonalds.ca/myrewardsterms) or on the McDonald's app. MyMcDonald's Rewards Points Prizes won in the Game will be deposited in your McDonald's app account when you win the Prize.

#### **5. Claim A Ten Dollar Or Fifty Dollar McDonald's Card Prize:**

**(a) Deadline: Claim by 11:59:59 p.m. on November 25, 2024.**

**(b) To Claim:** To claim a Prize of a Ten Dollar or Fifty Dollar Instant Win McDonald's Card Prize, a Participant with an Instant Win Game Stamp that indicates a Ten Dollar or Fifty Dollar McDonald's Card Prize first must visit a participating McDonald's restaurant in Canada and ask for the McDonald's restaurant manager to obtain a new/empty McDonald's Card. Participant should show the potential winning Game Stamp to the restaurant manager, but not give the Game Stamp to the manager or any other restaurant employee, as the Participant will need to keep it. That new/empty McDonald's Card will not be activated but will come with instructions informing the Participant on how to begin to claim the McDonald's Card Prize. Follow the claim instructions in Rule VI.B. to begin the Prize Claim Process in the McDonald's app to activate this McDonald's Card Prize. You (and your parent or legal guardian if Participant is a Minor) will be prompted to provide the 20-digit McDonald's Card number found on the back of the McDonald's Card obtained from the restaurant manager and your Game Stamp Code.

#### **6. Claim A Non-Food Prize (Except McDonald's Cards) Under Two Thousand Dollars:**

**Note:** Subject to the provisions of these Official Rules, Participants should not show or give any Instant Win Non-Food Game Stamp, any potential Winning Combination of Game Stamps, any Code, any Game Materials and/or any Declaration and Release to any

McDonald's employee. McDonald's employees can only verify and award Instant Win Game Stamps for Food Prizes.

**(a) Deadline: Claim by 11:59:59 p.m. on November 25, 2024.**

**(b) To Claim:** Follow the claim instructions in Rule VI.B. to begin the Prize Claim Process in the McDonald's app. If the Prize claim is correctly completed, Prize claim will be verified by the Redemption Centre and the Prize claimant will receive an email with instructions to receive the Prize at the Prize Partner's website or other location noted in the instructions, or the Prize will ship to the address provided during the Prize Claim Process for delivery in approximately four to six weeks.

#### **7. Claim A Non-Food Prize Two Thousand Dollars and Above:**

**(a) Deadline: Claim by Toll-Free Number or in the McDonald's app by 11:59:59 p.m. on November 25, 2024. Submit Game Materials (see below) to actually be received by the Redemption Centre by December 9, 2024.**

**(b) Claim Via The Toll-Free Number:** If a Participant wishes to claim a Collect to Win Prize by calling the toll-free number (when available) on the Game Stamp, in that call, a recorded message from the Redemption Centre will encourage the potential winner to claim their Prize in the McD's app by following the instructions in Rule VI.B. The message will also instruct the caller that if they are unable to claim in the McD's app, they may leave a message containing all of the information described by the Redemption Centre in that recorded message. When the Redemption Centre receives that information from the potential Prize winner, it will contact the potential Prize winner by telephone, and if the potential winner is unable to claim in the McD's app, the Redemption Centre will send the Declaration and Release to the potential Prize winner, by mail or by email, to the mailing address or email address the Redemption Centre obtains from the Participant in the return phone call.

Once the Redemption Centre provides a potential winner with instructions to submit the Game Materials necessary to claim a Prize, Participants must return their completed Game Materials using Canadian Postal Service registered mail. The mailing or other

transmission of Game Materials (including, without limitation, a Declaration and Release and any related Game Stamp(s)) does not constitute proof of actual delivery of those Game Materials to the Redemption Centre and does not constitute proof of actual receipt by the Redemption Centre of those Game Materials. When Participants send Game Materials to the Redemption Centre, it is strongly recommended that they obtain insurance for the Game Materials and the mailing. Prior to mailing Game Materials, Participants should photocopy for their records all Game Materials being submitted, including without limitation the signed and completed Declaration and Release and any potential winning Game Stamp(s). The status of Prizes claimed via the toll-free number and/or via mail will not be updated in the McD's app in your profile.

**(c) Claim Via the McDonald's app:** Follow the claim instructions in Rule VI.B. to begin the Prize Claim process in the McDonald's app. Then the Participant will be required to complete a Declaration and Release Form as described below to complete the Prize Claim Process and be eligible to receive the Prize. If the Prize you are claiming requires a Declaration and Release, you will receive an email from DocuSign that contains a link to a Declaration and Release form that you must electronically complete where required. Print and return the Declaration and Release by mail to the address provided in the instructions. You will be required to submit your Game Stamp(s) along with the copy of the Declaration and Release by mail to the Redemption Centre.

**No Printer?** If you do not have a printer and are unable to download and/or print the Declaration and Release sent by email, tap on the button on the Prize Claim screen and follow the instructions to have a Declaration and Release mailed to you. Once received, the Declaration and Release must be completed and returned with any required Game Stamps to the Redemption Centre.

For (b) and (c) above, a potential winner must ensure that any required Game Materials are actually received by the Redemption Centre by December 9, 2024. In the case of Prizes that require submission of Game Materials, Participants will not be considered winners of the Prizes until the Game Materials are verified by the Redemption Centre.

**D. Prize Verification/Notification:** In addition to other Game Materials required by these Official Rules, in order for a Participant to validly claim a Prize, in its sole discretion, the

Redemption Centre may ask a Participant to provide further documentation during the verification process. The nature and extent of such documentation shall be at the sole discretion of the Redemption Centre for the purposes, among other things, of confirming the Participant's eligibility and their compliance with these Official Rules. Without limitation, that documentation may involve proof of employment history to confirm eligibility and/or a form of government-issued photo identification (e.g., valid driver's license). A potential Prize winner may be requested to consent to a confidential background check conducted by or through the Redemption Centre, to help the Sponsor ensure that the Sponsor's use of such Participant in advertising or publicity will not bring the Sponsor or a Prize Partner into public disrepute, contempt, scandal or ridicule or reflect unfavourably on the Game or the Sponsor or on a Prize Partner.

**Game Materials sent by a Participant to the Redemption Centre will be reviewed by the Redemption Centre to verify the Participant's compliance with the Official Rules and to verify that the Participant is making a valid Prize claim. After the Redemption Centre has completed its review of a potential Prize winner's Game Materials the Redemption Centre will then notify the Participant:**

1. That the potential Prize winner **"is not verified"** as having won the applicable Prize, and that the applicable Prize is forfeited. In addition to any other event or situation referred to in these Official Rules which results in, or may result in, forfeiture of a Prize, forfeiture of a Prize will occur if the potential Prize winner does not submit the original potential winning Game Stamp or all of the original potential winning Game Stamps that comprise a Winning Combination, along with the required Game Materials for verification (when required). **Note:** Neither the Game Entities, the Prize Partners nor any other person or entity shall be liable or responsible for any failure on the part of a Participant to correctly follow, in full, the redemption instructions and procedures contained in or provided for pursuant to these Official Rules.

2. That the potential Prize winner **"is verified"** as having won the applicable Prize. Any potential Prize winner who is verified as a winner of a Prize will receive:

(a) either an email with the redemption code and/or the link to claim the Prize directly from the Prize Partner;

(b) a shipment of the Prize from the Prize Partner or the Redemption Centre; or

(c) notification of next steps concerning how to select/receive the applicable Prize.

**Rule VII: Prize Conditions/Limitations/Restrictions.**

**A. Travel Prize Conditions:**

Prize winner and guest(s) must travel together on the same itinerary and are solely responsible for having (and producing if/as required) any necessary travel-related documents (including valid government-issued photo ID and/or any required passport or visa and/or any properly completed and sworn parental consent form or forms) prior to departure, as well as fulfilling any/all travel and security requirements (including but not limited to any shots, medical tests or other health requirements necessary to visit certain destinations and any quarantine requirements that may be required). Each guest (and in the event of a Minor, their parent or legal guardian) will be required to execute a guest release prior to the issue of any travel documents. Any and all costs/fees (including, but not limited to, departure taxes or fees, inspection charges, luggage fees and the costs of transportation between winner's home and departure airport) and expenses not expressly stated as being included in the Prize description are the sole responsibility of the Prize winner. Any difference between the approximate retail value and the actual value of the Prize will not be awarded and any difference will not be refunded. No insurance whatsoever is provided as part of the Prize or furnished by the Sponsor or Prize Partner, and obtaining any insurance, such as (but not limited to) travel insurance, cancellation insurance, trip delay, health, accident or medical insurance, and property or luggage loss or other damage insurance is the sole responsibility of the Prize winner and at the sole cost of the Prize winner and that Prize winner's guest(s). Air travel will be round-trip (originate from and end at the same airport), economy-class from and to an airport selected by Prize Partner. Reservations must be made and tickets issued prior to travel. Tickets may not be reissued once travel has commenced. Open tickets may not be issued, and stopovers are not permitted. Sponsor or Prize Partner(s) reserve the right in their respective sole discretion to designate all flight/travel particulars and route or routes (as the case may be). Flight schedules are subject to change without notice. No Released Party will be liable for any missed opportunities or expenses incurred as a consequence of flight cancellation/travel restrictions/delay or ground transportation

delay. Sponsor and/or Prize Partner make no express or implied warranties of any kind with respect to safety, or performance, of the trip/travel services package or any component thereof. If a winner (and/or the winner's guest(s)) is/are not able to participate in any portion of a travel Prize, that unused portion will not be substituted for cash or in any other way. Prize winners may be required to provide a current valid major credit card at time of hotel check-in to cover incidentals, and any and all costs, fees and expenses not expressly stated as being included in the Prize description. Restrictions and/or blackout dates may apply to some travel Prizes. Once a winner has identified a guest in accordance with the provisions of these Official Rules, that guest cannot be changed without the express consent of Sponsor and/or Prize Partner, which consent may be withheld for any reason. Each travel Prize winner (and in consideration of being permitted by the Sponsor to participate in the travel Prize, each guest) agrees to maintain their dress, behaviour and comportment in accordance with all applicable laws and generally accepted social practices in connection with the travel related to the travel Prize and in connection with participation in any Prize-related event or activity. Travel Prize winners and their guest(s) understand and agree that the Sponsor and, when applicable, Prize Partner has/have the right, in its/their sole discretion, to disqualify and remove a Prize winner or any guest from any travel at any time if that winner or guest's behaviour at any point is uncooperative, disruptive or may or does cause damage to person, property or the reputation of the Sponsor, Prize Partner and/or any third party, or otherwise violates the policies of the Sponsor, Prize Partner or both. The Prize winner is entirely and solely responsible for the behaviour and comportment of their guest(s).

**Note:** No travel Prize winner or any of their guest(s) may sell, transfer or dispose of any part of any travel Prize to any other person without the Sponsor's and/or Prize Partner's prior written consent which may be withheld in their sole discretion.

**1. Universal Trip Prize Conditions** (UO Trip, USH Trip, UO VIP Trip and USH VIP Trip). Travel must be **completed by December 31, 2025**. Travel dates and arrangements are subject to air travel, holiday, blackout dates and other Trip Prize and travel restrictions. Travel dates are subject to Universal approval. Reservations are subject to availability. Trip must be booked at least sixty days prior to intended departure date. If a verified winner elects to partake in any or all portions of their Trip Prize with fewer than the allotted number of guests or no guests, the Trip Prize will be awarded to verified winner and each participating guest, and any remainder of the Trip Prize will be

forfeited and shall not be subject to further or alternative compensation. All elements of the Trip Prize must be claimed at the same time, and no changes will be permitted after confirmation of any redemption. If verified winner is between the ages of eighteen and twenty-one, they must be accompanied by an adult of at least twenty-one years of age in order to check into the hotel. Unless child or ward of verified winner or one of the allotted guests, each guest must be eighteen years of age or older as of the date of departure and all guests must travel on the same itinerary and at the same time as the verified winner. Tickets are non-refundable and non-transferable and are not redeemable for cash. Travel arrangements must be made through Universal. Travel, entertainment and theme park tickets are subject to certain terms and conditions as specified thereon. All the tickets are valid during normal operating hours only. Operating hours and availability of attractions and shows are subject to change without notice. Some special events may be separately ticketed. Universal reserves the right to change the name of all tickets. Unless otherwise noted, all tickets specifically exclude admission to special or separately ticketed "hard ticket" entertainment events at any of the theme parks, hotels or within any of the Universal CityWalk venues such as Hard Rock Live®. Verified winner and guests must comply with all venue rules and regulations. Failure to do so may result in forfeiture of such portion of the Prize. Notwithstanding anything to the contrary contained herein, all disputes, claims and causes of action against Universal Orlando Resort arising out of or relating to any person's use of or participation in the UO Trip or UO VIP Trip involving Universal Orlando Resort shall be resolved by applying the laws of Florida, without regard to conflict of laws provisions therein, and shall be solely and exclusively brought in state or federal courts within Orange County, Florida. Such claims shall be resolved individually, without resort to any form of class action, and all such claims shall be limited to actual out-of-pocket costs incurred, but in no event to include attorneys' fees. EXCEPT WHERE PROHIBITED BY APPLICABLE LAW, any disputes, claims and causes of action against Universal Studios Hollywood arising out of or relating to any person's use of or participation in the USH Trip or USH VIP Trip involving Universal Studios Hollywood shall be fully and finally adjudicated by binding arbitration to the fullest extent allowed by law (and "**Arbitration**") in Los Angeles, California. The Arbitration shall be administered by JAMS in accordance with the Streamlined Arbitration Rules and Procedures of JAMS (available at <https://www.jamsadr.com/rules-streamlined-arbitration/>) or subsequent versions thereof, including the optional appeal procedure. Please be advised that Universal's



policies, CDC guidelines and the recommendations of health officials must be followed. In addition, guests should be aware of and comply with government guidelines regarding travel restrictions and mandatory quarantines before visiting any Universal destination. **Please note that any public location where people are present provides an inherent risk of exposure to infectious disease such as COVID-19, and Universal cannot guarantee that any person will not be exposed during a visit.**

**2. Universal VIP Experience Prize Conditions.** Separate theme park admission required for all VIP Experiences. Unless otherwise stated, does not include admission to separately ticketed events at any of the Universal theme parks or within any of the CityWalk venues, Universal Cinemark or Hollywood Drive-In Golf™ and parking or discounts on food or merchandise. Some CityWalk venues require ages twenty-one or older for admission. Valid Photo ID required. Additional restrictions may apply, and benefits are subject to change without notice. VIP Experiences are available every day. Reservations are strongly recommended, as inventory is limited. VIP Experience admission must match the same date and park chosen for theme park admission.

**3. Sunwing Prize Conditions.** Sunwing Airlines does not operate year-round in many Canadian gateways, and if Sunwing Airlines has stopped flying for the season out of your closest Canadian gateway for your requested travel dates, it is left at your

responsibility (the Prize winner) to make your way to the next closest Canadian gateway with operating flights for your requested departure dates.
